ATEC Fork Lift Driving Licence Qualification (for Experienced Drivers – 18 yo+)

Part of Cert 1 Metal & Engineering Industry Training Package (MEM 10105 V 2.2)

This course has been devised to provide students with the basic skills necessary to drive a forklift and to gain practical experience. Students are expected to undertake 30 hrs homework prior to the course at Lonsdale.

This course is for students who have very good co-ordination and have had some experience steering either on-road or off-road vehicles (car, motor bike, go cart, tractor) only and is shorter in duration than the course for Beginners.

Desired attributes:	Have driving experience by regularly driving or steering a vehicle (as above) and have good co-ordination skills. Students must be 18 years of age.
Career Pathways:	This qualification and experience is very useful for a number of industries including transport and logistics, metal and engineering, civil construction, general construction. Refer to www.myfutures.edu.au for career pathway information.

Work Placement:	Nil – not applicable
Student requirements:	<ul style="list-style-type: none"> ⇒ Must be 18 years of age to undertake this training and to receive a forklift licence. Proof of identity (DoB or age and photo) must be presented on the first day. ⇒ Must have had some steering experience of a motorised vehicle (forklift steering is more difficult than that of a power assisted 4 wheel vehicle) ⇒ Having a driving licence is NOT a prerequisite, but ownership is preferred. NB: even with a forklift licence, it is illegal to drive a forklift on roads or any area the public can access without a normal car driving licence). ⇒ Students must wear steel capped boots and neat working clothing – jeans, overalls OK. ⇒ To improve quality each student will be issued with a booklet, with the expectation they will read and study prior to the course to gain knowledge for subsequent testing. ⇒ If ill, it is expected that the student will phone the Automotive Office on 8186 5299 the morning of the absence. ⇒ No shops nearby – lunch van calls (more expensive than school canteens)

Class restraints:	Maximum of 6 students per class, minimum of 8
School requirement:	<u>Student selection criteria:</u> This class is for students with driving experience who regularly drive or steer a vehicle (car, motor bike, go cart, tractor) and who have good coordination skills. Forklifts can be difficult to control.
